Data protection

We take the protection of your personal data very seriously.

We treat your personal data confidentially and in accordance with the statutory data protection regulations and this privacy policy.

Collection of personal data when using our website.

Personal data is all data that can be related to you personally, e.g. name, address, e-mail addresses, user behavior.

The controller pursuant to Art. 4 (7) of the EU General Data Protection Regulation (GDPR) is :

The use of our website is generally possible without providing personal data. Insofar as personal data is collected, this is done on a voluntary basis. This happens, for example, when you contact us by e-mail.

The data you provide (your email address, possibly your name and telephone number) will be stored by us in order to answer your request.

The data collected in this context will be deleted after storage is no longer necessary, or processing will be restricted if there are statutory retention obligations.

The legal basis for data processing for the purpose of contacting us is Art. 6 para. 1 sentence 1 lit. a GDPR on the basis of your voluntarily given consent.

If we use contracted service providers for individual functions of our offer or would like to use your

data for advertising purposes, we will inform you in detail below about the respective processes. We will also state the specified criteria for the storage period.

Rights of the data subject

You have the following rights at all times with regard to your personal data:

- Right of access, Art. 15 GDPR
- Right to rectification or erasure, Art. 16, 17 GDPR
- Right to restriction of processing, Art. 18 GDPR
- Right to data portability, Art. 20 GDPR
- Right to object to the processing, Art. 21 GDPR

Objection or revocation against the processing of your data

If you have given your consent to the processing of your data, you can withdraw it at any time. Such a withdrawal will affect the permissibility of processing your personal data in the future.

You can object to the processing of your personal data for advertising and data analysis purposes at any time. You can inform us of your objection using the following contact details:

If the legal basis for the processing of your personal data is our legitimate interest, you can object to the processing.

We ask you to state the reasons why we should not process your personal data as we have done. In the event of your justified objection, we will examine the situation and either stop processing the data or show you our compelling reasons worthy of protection on the basis of which we will continue the processing.

To do this, please contact us by email (see above).

You also have the right to complain to a data protection supervisory authority about the processing of your personal data by us.

Collection of personal data when visiting our website

When you visit the website, only the personal data that your browser transmits to our server is stored. In this case, only the data that is technically necessary for us to display our website to you and to ensure stability and security is collected:

- IP address
- Date and time of the request
- Time zone difference to Greenwich Mean Time (GMT)
- Content of the request (specific page)
- Access status/HTTP status code
- amount of data transferred in each case
- Website from which the request originates
- Browser
- Operating system and its interface
- Language and version of the browser software

The legal basis is Art. 6 para. 1 sentence 1f GDPR, the legitimate interest.

Server log files

The website operator or site provider collects data about access to the site and stores it as server log files. The following data is logged:

- Visited website
- Time at the time of access
- Amount of data sent in bytes
- Source/reference from which you reached the page
- Browser used
- Operating system used
- IP address used (if applicable: in anonymized form)

The data collected is only used for statistical analysis and to improve the website. However, the website operator reserves the right to check the server log files retrospectively if there are concrete indications of illegal use.

According to Art. 6 para. 1 lit. b GDPR, the legal basis is the fulfillment of a contract or pre-contractual measures.

Use of cookies:

Therefore, you will not be bothered with a cookie banner.

A default installation of [DokuWiki](#) sets **three cookies**:

DW<hash>

Is used for authentication after login. It contains the data required to (re)log in a previously authenticated user.

- Importance: **necessary** for anyone who needs to log in
- Typical content: encrypted user name and password
- Expires: in one year ¹⁾

DOKU_PREFS

Used to remember helpful user settings, such as the size of the editor text field.

- Importance: **functional**
- Typical content: name/value pairs in plain text
- Expires: in one year

DokuWiki

The default PHP session identifier. Used to hold temporary data and to avoid CSRF attacks.

- Importance: **necessary**
- Typical content: random ID
- Expires: at the end of the browser session

You can delete the cookies at any time in the security settings of your browser.

You can set your browser so that you are informed about the setting of cookies and only allow cookies in individual cases, exclude the acceptance of cookies for certain cases or in general and activate the automatic deletion of cookies when closing the browser. If cookies are deactivated, the functionality of this website may be restricted.

SSL or TLS encryption

This site uses SSL or TLS encryption for security reasons and to protect the transmission of content. You can recognize an encrypted connection by the fact that the address line of the browser changes from `http:` to `https:` and by the lock symbol in your browser line.

If SSL or TLS encryption is activated, the data you transmit to us cannot be read by third parties.

YouTube

The legal basis is Art. 6 para. 1 lit. f GDPR.
